Clinical Negligence

Andrew is ranked as a Star Individual at the North East Bar for his Personal Injury work by Chambers & Partners.

- Obstetrics – 3 x cerebral palsy – profound disability
- Paediatrics – congenital metabolic disorder; delayed diagnosis – hydrocephalus – profound disability
- Hypoxic brain injury caused by unplanned extubation – profound disability.
- Spinal – spinal surgery – tetraplegia – profound disability; cauda equina – delayed diagnosis
- Oncology – delayed diagnosis of: cervical, lung and breast cancers – fatalities
- Vascular – Amputation – lower limb – radiological misdiagnosis; treatment delay diabetes; missed progressive arterial disease
- Psychiatric – self harm during psychosis

Notable Clinical Negligence cases

CEREBRAL PALSY (2018)

Complex Cerebral Palsy case involving a dispute concerning interpretation of the trace and the appropriate response of clinicians. Case concluded with a value of £14.3 million which was settled as a lump sum and Periodical Payments Order.

DELAYED DIAGNOSIS BRAIN TUMOUR (2018)

Cerebral Palsy case leading to profound disability and 24-hour care regime. Case concluded with capital sum £4.1 million and Periodical Payments Order rising £79k to £145k to £165k – Capitalised value: £13.5 million.

DELAYED DIAGNOSIS CHOROID PLEXUS CARCINOMA (2018)

Child with co-morbid learning difficulties – blindness caused by breach of duty. Causation disputed. Case concluded with capital sum £1.25 million and Periodical Payments Order rising £42k to £82k to £100k – Capitalised value: £11 million.
